The White Mountain Water and Sewer District is pleased to present this year's Annual Water Quality Report. This report is designed to inform you about the quality of water and services we deliver to our customers every day. It is our commitment and our goal to provide you a safe and dependable supply of drinking water. The District purchases our water from the Green River-Rock Springs-Sweetwater County Joint Powers Water Board which is treated surface water from the Green River.

We are pleased to report that your drinking water is safe and meets federal and state requirements.

If you have any questions regarding this report or concerning your water utility, please contact Max Casey Olguin, Monday through Friday, 9:00 A.M. to 5:00 P.M. at 362-3937. We want our valued customers to be informed about their water utility. If you have any other questions or concerns regarding the District, as always, we invite you to attend our regularly scheduled meetings. Our meetings are held on the second Tuesday of each month at 7:00 P.M. at the District office located at 54 Gannett Drive. Because our water is treated by the Joint Powers Water Board, you may also wish to contact Robin Toone at the water treatment plant at 875-2957 or attend one of their meetings which are advertised and held on the fourth Thursday of each month.

The water plant routinely monitors for constituents in your drinking water according to Federal and State laws. The following table shows the results of their monitoring for the period of January 1, to December 31, 2014. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It is important to remember that the presence of these constituents does not necessarily pose a health risk.

In this table you will find many terms and abbreviations that you might not be familiar with. To help you better understand these terms, we have provided the following definitions:

Parts per million (ppm) or Milligrams per liter (mg/L) Represents the unit of measure for the concentration of a contaminant in the water – One part per million corresponds to one minute in two years, or one penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter (ug/L) Represents the unit of measure for the concentration of a contaminant in water - One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Nephelometric Turbidity Unit (NTU) - Nephelometric Turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

Variances & Exemptions (V&E) - State or EPA permission not to meet an MCL or a treatment technique under certain conditions.

Action Level(AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Treatment Technique (TT) - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

Maximum Contaminant Level (MCL) - The highest level of a contaminant that is allowed in drinking water. MCL's are set as close to the MCLG's as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG)- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLG's allow for a margin of safety.

Turbidity is reported as the highest single measurement and the lowest monthly percentage of samples meeting the turbidity limits specified for the filtration technology being used. Turbidity has no health effects. However, turbidity can interfere with Disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea, and associated headaches.

Both systems (The Joint Powers Water Board and the White Mountain Water and Sewer District) had no violations. We're proud that your drinking water meets or exceeds all Federal and State requirements. Through their monitoring and testing the Joint Powers Water Board has learned that some constituents have been detected. The EPA has determined that your water is SAFE at these levels.

The sources of drinking water include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it can dissolve naturally occurring minerals and in some cases, radioactive materials. The water can also pick up substances such as:

- (1) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural operations and wildlife.
- (2) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.

- (3) Pesticides and herbicides, which may come from agriculture, urban storm water runoff, and residential uses.
- (4) Organic chemical contaminants, which can come from industrial processes, gas stations, urban storm water runoff and septic systems.
- (5) Radioactive contaminants, which can be naturally occurring or the result of oil and gas production, and mining activities.

In order to ensure that tap water is safe to drink, EPA establishes regulations which limit the amount of certain contaminants in water provided by public water systems. The Food and Drug administration establishes limits for contaminants in bottled water.

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Green River-Rock Spring-Sweetwater County Joint Powers Water Board and White Mountain Water and Sewer District are responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Some people may be more vulnerable to contaminants in drinking water than the general population. Immune-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791). Ingestion of *Cryptosporidium* may cause cryptosporidiosis, an abdominal infection. Symptoms of infection include nausea, diarrhea, and abdominal cramps. *Cryptosporidium* must be ingested to cause disease, and it may be spread through means other than drinking water.

The Green River-Rock Springs-Sweetwater County Joint Powers Water Board was required to start monitoring the Source (the river) on a monthly basis for *Cryptosporidium* from April 2008 to March 2010. In November 2009 *Cryptosporidium* was detected at a 0.1 cysts/L concentration. This was the only time any *Cryptosporidium* was detected in the Source water. The Green River-Rock Springs-Sweetwater County Joint Powers Water Board's water treatment plant was designed with filtration plus an ozone disinfection system to specifically address microbial and other organic contaminants in the source water.

The Green River-Rock Springs-Sweetwater County Joint Powers Water Board and the White Mountain Water and Sewer District's Board and their staff members work hard to provide and maintain a safe and dependable water supply. We ask that all of our customers help us protect our water sources, which are the heart of our community, our way of life and our children's future.
